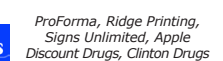

UT-Battelle funds pilot program to help families reduce energy usage

100 local families will soon learn how to significantly reduce energy consumption and lower utilities bills, thanks to a new program funded through a partnership with UT-Battelle.

The pilot program will offer free Weatherization Workshops to clients served by ADFAC's Social Services program. The Workshops will include discussion on how to further

reduce energy consumption through simple changes in their homes and basic preventive maintenance education.

Participants completing the workshop will receive one Weatherization GreenKit. The GreenKits, valued at \$40, will contain a variety of simple energy-saving items such as weather stripping, CFL light bulbs and rope caulk.

"We are so excited to have the opportunity to provide materials and education to help families lower energy consumption," said Liz Herbes, Director of ADFAC's Social Services program.

"These efforts will help low-income families reduce their overall housing burden - an important step in achieving self-sufficiency."
